All necessary details including eligibility criteria, terms and conditions and application form (Annexure-I) shall be obtained from either College campus or from college website (www.gdcramgarh.in)

EOI from eligible parties in sealed envelope clearly superscripted as "Invitation for Expression of Interest" EOI for empanelment for supply of books to "GDC, Ramgarh Library" should reach this office within 10 days of publishing of this notice in different newspapers.

Eligibility Criteria

Proof of following mentioned documents must be enclosed in support of the eligibility criteria and absence of any of them will render the vendor/supplier ineligible for empanelment.

1. Book seller /Vendor/Publisher must be a regular service provider to at least three premium institutes of higher Education of J&K UT during the last three years.
2. Registration with Federation of Publishers and Book sellers Association of India (FPBAI).
3. Permanent Account No. (PAN) issued by the Income Tax Department).
4. Evidence of income Tax clearance certificate for the last three years.

TERMS AND CONDITIONS

The firms /Vendor which applies for empanelment should fulfill following conditions:

1. The period of empanelment shall be for the financial year 2023-24 and 2024-25.
2. The firms /vendor has to supply books to the College offering a –uniform discount rate that shall be communicated once firm is empanelment by the College.
3. The books without price proof shall not be accepted.
4. Rate printed/written on stickers shall not be accepted. Books with printed price shall only be accepted.
5. The last edition of books shall only be accepted.
6. Any loss/damage caused to the supplied consignment during transit shall be the sole responsibility of the supplier. The cost of packing / freight charge /loading etc. at the ends shall be borne by the supplier.
7. Payments of books shall be made after proper verification of each title and author by the concerned HOD/Teacher/librarian.
8. Security deposit in the form CDR amount to Rs. 10000/- (Ten thousand only) should be pledged to the Principal Government Degree College Ramgarh, security deposit in the shape of Cheque/cash shall not be accepted.
9. The supply is to be made within 15 days from the date of issuance of supply order failing which firm may be penalized.
10. Conversion rate for the foreign currencies as recommended/approved by goods Office Committee, New Delhi shall be enclosed.
11. Orders will be placed by Principal and it will be discretion of his/her to place order to any empanelled supplier. There will be no objection from other empanelled suppliers in this regard.
12. All the pages of the empanelment documents are to be signed and stamped by the firm and to be submitted along with the application form and self – attested copies for documentary proof.
13. The bill in triplicate should be raised in the name of Principal, Govt. Degree College, Ramgarh.
14. The College reserves the right to modify any condition enumerated or arising out of this notice without assigning any reason thereof.
15. In case of foreign edition, a certificate would be required stating that "Indian reprint/edition is not published" likewise for hardbound "Low price editions/paperback edition for books is/are not published".
16. All the payments will be made in INR and the payment will be released after supply and acceptance of books by the College.
17. All orders shall be F.O.R College premises.

Note:

1. Absence of any of the above – mentioned documents shall render the supplier ineligible for the empanelment.
2. All the vendors who accepted the above terms and conditions may submit their Expression of interest (EOI) through Annexure-I on uniform rate of discount for supply of books in a sealed envelope in bold letters EXPRESSION OF INTEREST at mailing address of College.
